RESOLUTION 2009 - 25

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Civic Building on October 13, 2009 with the following members present: Robert McGee, Matthew Beamer, Timothy Donnellon.

MR. DONNELLON made a motion to adopt the following Resolution:

RESOLUTION SUPPORTING THE VACATING OF A SECTION OF CORNSTALK LANE (T-622)

WHEREAS, the Board of County Commissioners have been petitioned by abutting property owner(s) to vacate a section of Cornstalk Lane (T-622) pursuant to Section 5553.03, et. al. of the Ohio Revised Code, and have requested the Board of Trustees of Union Township to adopt a Resolution supporting the road vacating request; and

WHEREAS, the section of Cornstalk Lane proposed to be vacated no longer serves as a functioning roadway in the Union Township Road System.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Union Township, Clermont County, Ohio as follows:

SECTION 1: That the vacating of Cornstalk Lane will have no negative impact on the Union Township Road System.

SECTION 2: That the Miami Township Board of Trustees supports the vacating of a section of Cornstalk Lane (T-622) as defined by Exhibit A attached hereto.

SECTION 3: That the Fiscal Officer of Union Township Trustees certify a copy of this Resolution to the Board of County Commissioners of Clermont County, Ohio, with the request to proceed immediately pursuant to Sections 5553.03, et. al., of the Ohio Revised Code to vacate said road or portions thereof.

SECTION 4: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution shall take effect at the earliest period allowed by law.

MR. BEAMER seconded the motion to adopt the Resolution. On the roll call being called the vote resulted as follows:



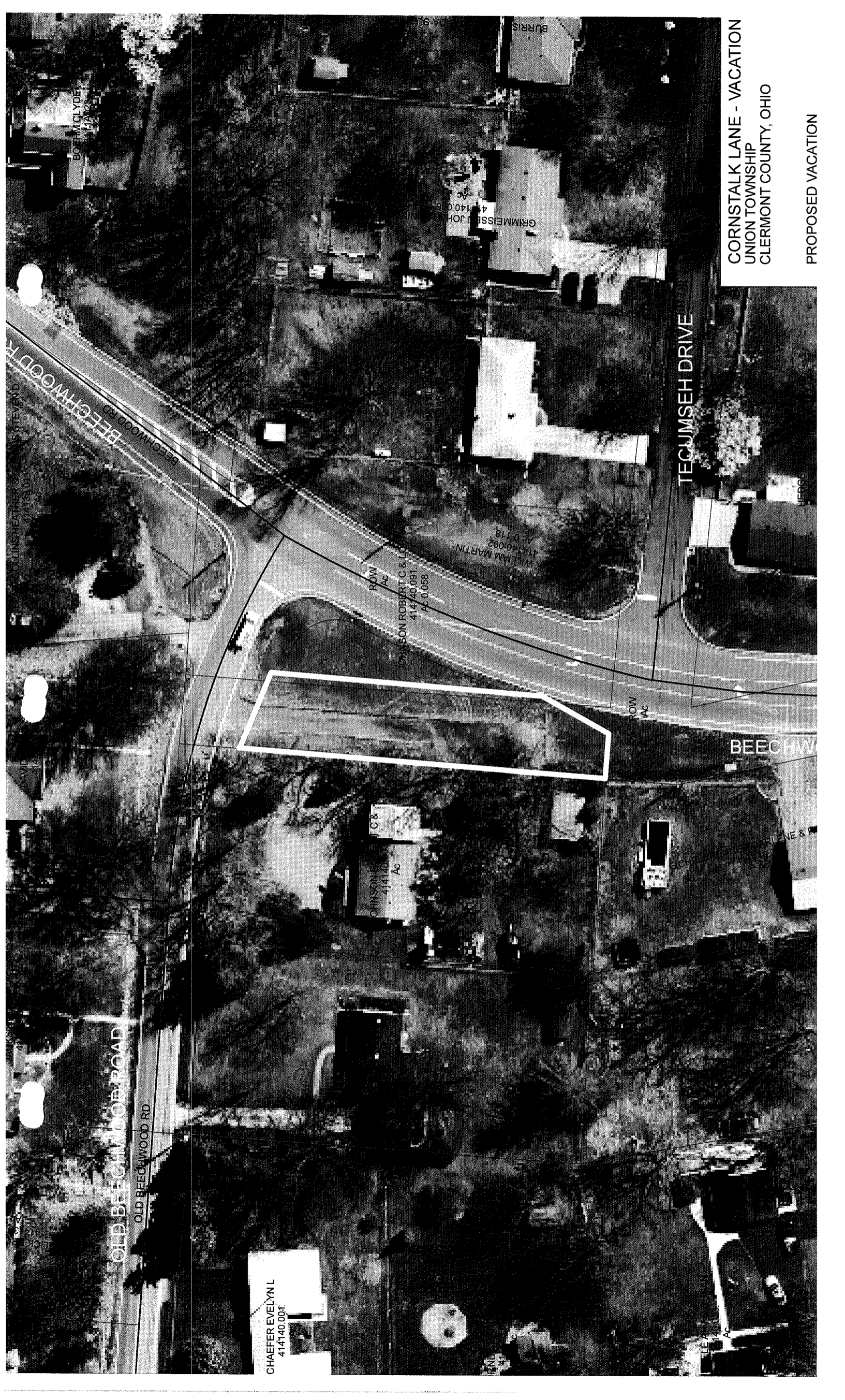
EXHIBIT A
